Every other year young artists from all over Europe meet in Wiesbaden at one of Europe's most important artistry festivals - the European Youth Circus.

## TERMS OF PARTICIPATION

All European artistes from 12 to 25 years of age are called upon to participate. Participants at the European Youth Circus will be chosen by an international committee based on the applications submitted. An international jury (experts from the European circus and variety scene) determines the winners using a scoring system. **The members of the selection committee and the jury are not permitted to register any artistes they are training or taking care of.**

- Technical performance
- Presentation and personal charisma
- Idea and innovation

- Artistes and their accompanying persons will receive an allowance for **travel expenses.**
  - **Accommodation and catering** will be provided free of charge from Sunday, 21 to Monday, 29 October 2018.
  - **Performances with animals** are not permitted.
  - Your **application** shall contain the following:
    - Application form
    - Copy of passports/identity cards of all artistes and their accompanying person(s)
    - Video of your performance, optionally as
      - DVD
      - Video file on a USB memory stick or as
      - "direct-download" video file on the Internet (WITHOUT any password/registration requirement).
- Pay attention for a high quality recording.

## DECLARATION

Upon signing the application the participants acknowledge the Terms of Participation and the fact that rehearsals and the performances/shows themselves may be recorded by a television crew. The Municipal Institute for Cultural Affairs reserves the unrestricted right to use the submitted images and videos for printed materials and electronic media associated with advertising measures undertaken for the European Youth Circus.

The Municipal Institute for Cultural Affairs Wiesbaden cannot be held liable for any injuries, accidents or illnesses incurred by the artistes during their stay in Wiesbaden. The artistes themselves are responsible for taking out appropriate insurance cover.

The Municipal Institute for Cultural Affairs shall not be liable for any damage to, or theft of, the props or costumes.

The artistes perform their acts under their own responsibility and declare that their technical equipment complies with the generally accepted engineering standards and current safety standards. The artistes shall perform their acts without causing any harm to the visitors of the event.

The artistes undertake to arrive in Wiesbaden on Sunday, **21 October 2018** and to take part in all rehearsals, competitions and - in the event of being awarded by the jury - in the Gala Shows.

The number of accompanying persons for performances involving up to four artistes is limited to one person. For performances with five or more artistes two accompanying persons are permitted. Additional accompanying persons shall pay for their own travel expenses, accommodation and catering.
