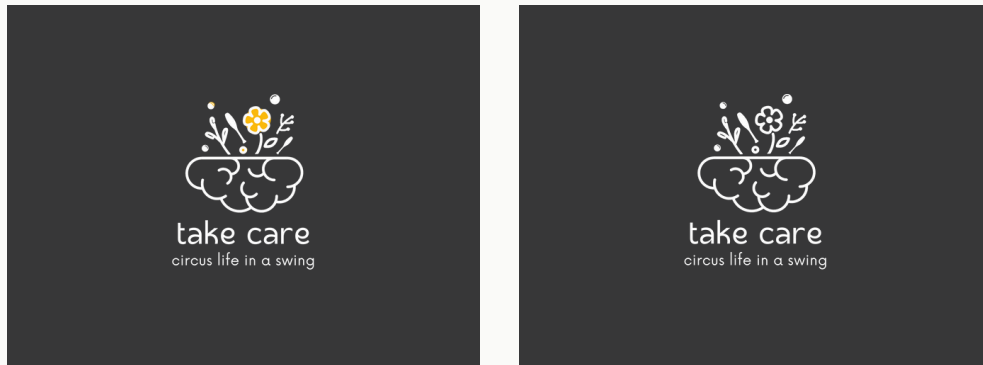


Horizontal

## Correct use of the project's name

To ensure consistency and maintain the visual identity of the project, the project name must always begin with an uppercase letter, followed by lowercase letters, as follow: **Take Care**.
